### ORDER:

In the Government Order 1<sup>st</sup> read above, Government have issued orders reconstituting the Tamil Nadu State Haj Committee with 12 members nominated by the Government as per section 18(1) of the Haj Committee Act, 2002 (Central Act 35 of 2002), with effect from 15.06.2020. Subsequently, after the expiry of one Member of Parliament, two Members of Legislative Assembly and resignation of 6 members of Tamil Nadu State Haj Committee, the Government in the Government Order 3<sup>rd</sup> read above, appointed 9 members to the Tamil Nadu State Haj Committee for the remaining terms of the former members.

The term of office of the said Committee is 3 years. The tenure of the said Committee expired on 14.06.2023.

- 2. Consequent to this, the Secretary and Executive Officer, Tamil Nadu State Haj Committee in his letter 4<sup>th</sup> read above has sent detailed proposal to Government for the nomination of persons representing different categories as prescribed in the Haj Committee Act, 2002 and requested the Government to re-constitute the Tamil Nadu State Haj Committee.
- 3. The Government have carefully examined the above proposal and accordingly re-constitute the Tamil Nadu State Haj Committee and nominate the following persons as Member of the Tamil Nadu State Haj Committee under sub-section (1) of section 18 of the said Act, 2002 read with Rule 4 of the Tamil Nadu State Haj Committee Rules, 2019:-

- 2. In the Government order second read above, the Government have issued orders for notifying the appointment of Thiru.K. Navaskani, Member of Parliament, as a Chairperson of the Tamil Nadu Waqf Board.
- 3. The Secretary and Executive Officer, Tamil Nadu State Haj Committee in his letter third read above, has requested the Government to issue orders appointing Thiru. K. Navaskani, Member of

Parliament and Chairperson of Tamil Nadu Waqf Board as a member of the Tamil Nadu State Haj Committee according to section 18 (1) (v) of the Haj Committee Act, 2002 (Central Act 35 of 2002) and notify the same in the Government Gazette.

- 4. After careful examination, the Government have decided to appoint Thiru. K. Navaskani, Member of Parliament as a member of the Tamil Nadu State Haj Committee under the category of the Chairperson of State Waqf Board under clause (v) of sub-section (1) of section 18 of the Haj Committee Act, 2002 (Central Act 35 of 2002).
